- B. Close supervision with a state beauty pageant coordinator and to have an open communication between NBDA and BDA Chapters. This is our hope to develop a positive relationship in providing services for your chapter reign.

C. Please provide the name of appointed state pageant coordinator and email address. This way, a director can have access to communicate with them such as sending a beauty pageant newsletter and maintaining up to date announcements.
